#### 3. COMMITMENT

#### 4. CONSENT

By using the internet site each user agrees to the content of the present conditions and, more particularly, agrees to the way in which the information is collected and used by Colasse sa;

#### 5. COOKIES

During creation of the profile on the site <u>www.lumipower.eu</u> a "cookie" may be temporarily created on the hard drive of your computer.

This information connects the user profile to the referent partners.

This cookie is automatically deleted after creation of the profile.

#### 6. USE AND TRANSFER OF DATA

Respect of privacy is a major priority for Colasse sa, the company strictly refuses to sell or distribute the collected information to other companies.

Colasse sa may however be required to communicate a part or the entirety of such information to judicial or legal departments guaranteeing the protection of data collected within the limits of the present agreement.

When registering on the site <u>www.spotled.be</u> the user is asked to give his authorization or not for the sending of a presentation newsletter of products and novelties;

This authorization may be changed at any time by a connection on the internet site.

Colasse sa may however be required to send an e-mail outside the scope of the newsletter in order to communicate information concerning an order and/or developments within the company.

By using the website to buy Products you agree to the transmission by Colasse sa of subsequent (and non-updated) information to third parties (for instance, banks and factoring services) in order to validate a payment or obtain a credit opening or the authorization of transactions for individual purchases.

Colasse sa processes and keeps this data only as long as absolutely necessary for the correct execution of the transaction in question, after which it is destroyed.
